Ni moa man 1 ni Beberuare 2023 ngkana ko tangiria ni kan karekea am raitienti ae boou ibukin karaoan mwakuri iaon reiakinaia ataei aika uarereke ao ko riai ni karekea moa te kariaia man te Botaki ibukin Babairean te Reitaki ae mena iaan te Minita ibukin Reirei imwain ae ko karokoa am bubuti ibukin te kareke raitienti.

Bwaninin rongorongan karekean te kariaia man te Rabwata ni Babaire ibukin Reitaki a kona n noraki n te kibu 17 ao 18 iaan te Tua ae te Education and Training Act 2020 (the Act).

Iai uoua mwakoron te Rabwata ni Babaire ibukin Reitaki ibukim ngkoe te tia bubuti ae ko riai ni kaoti:

 - Rinanoan te konabwai iroun te Tia Koroboki, tauia ao akean barekaia butiraoin aia waaki n aia mwane
 - Bubuti ibukin bitakin te kariaia ibukin tararuan te reitaki n aron ae kantaningaki n te tua, n aron te bong are e a toki iai ke bwai aika a tangiraki
5. Tauan muin kariaia ibukin tararuan te reitaki ao kamaunyan moti aika tao a na aki kaotaki n tuua aikai
